• **Retirements**: Last June CalSTRS experienced one of its greatest numbers of retirees. We know that many chapters have members retiring right now. Please send to retiree information to your local reps at your RRC regional meetings or to our **Northbay contact**, Celia Lamantia at <u>farli@aol.com</u>.

• Suspension of 180-day Return Prohibition: In August 2021 Governor Newsom signed an Executive Order temporarily suspending the "180-day prohibition" from going back to CalSTRS work with a school district. This includes subbing and the dire need for subs up and down the state. There are specific allowable and non-allowable to this suspension of ordinary rules; no retirement incentive takers, no back-filling of one's previous position, and the yearly earning limit is still in place. You may not work 1 minute without prior CalSTRS approval. The district must send this to CalSTRS, it does not have to go before the school board. Be sure your district knows the rules!

• Northbay is very concerned that CalRTA, a non-union retired organization is using its friends in Administration to communicate, offer money, and workshops to our members. We have spent a year communicating with different departments in CTA to take action to stop this practice. Unfortunately it has been cast as a "CTA Retired" issue and don't understand the fury that is experienced by members who know that they are not CTA and gullibility by members who think that they are dealing with CTA. **The answer some have come up with is the local chapter has to kick CalRTA out**. Northbay will keep knocking on CTA doors until there is understanding that this is a CTA issue that has dire long term negative results.

• CalSTRS is Healthy: Please let it be known that the CalSTRS Fund and its investment returns have been doing very well of late. CalSTRS has reported a 27.2% net investment return for fiscal year 2020-2021 which is a record fund performance rate.

• **Retirement Workshops**: For 2021-2022 Northbay and CTA RRC UniServ staff have worked together to organize CTA **Retirement Workshops** for active members who are ready to learn about the CalSTRS Retirement process. The presentations will be virtual and this will allow us to reach out to members in all areas of CTA/NEA-Retired Northbay This year we believe the presentation can reach more members because we are prepared for registration and each session cam accommodate 300 of members instead of a tight cap of 100. Northbay will be included with our message of the value of Retired Membership and our popular door prizes. The first one is scheduled for October 26, 2021 and the second, February 8, 2022.

• **Special Webinars**: In May 2021 CTA/NEA-Retired collaborated with CTA and CTA/NEA Member Benefits. Two webinars were advertised and presented to CTA members who were fifteen years or fewer out from retirement. CTA/NEA-Retired intends to advertise and repeat these webinars for 2021-2022.

• **Disaster Relief**: Both Active and Retired members are eligible for CTA Disaster Relief. Northbay works seamlessly with CTA Regional staff and leadership to make sure that retirees don't get overlooked. If you know

of a CTA Retired member who suffered a loss or was in a mandatory evacuation situation, please contact one of our Northbay Vice Presidents: Celia at <u>farli55@cta.org</u> or Sue at <u>sholland524@att.net</u>. CTA Disaster Relief information is available at <u>www.cta.org</u> (Member Benefits) or <u>www.cta.org/retired</u> (Member Benefits). Northbay recently met with CTA Member Benefits to discuss some concerns that we have for our Retired members when they are impacted by disaster. Northbay has the misfortune to have had Wildfires, smoke, PSP and evacuations every year since 2015 in one or more of our eight counties.

• CTA/NEA-Retired Political Activity: Here's what we know: CTA/NEA-Retired members statewide worked the NO on Recall Campaign by writing postcards, contact through emails, and phone calls. NEA/CTA-Retired Northbay discussed the NO on Recall at our meetings and sent a very concise message out to every member. CTA/NEA-Retired leadership activated the retired **RAN (Retiree Action Network)** to contact California legislators in **support of AB 388** to give permanent status to the "forgotten" adult Ed, career technical instructors, and teachers in small districts.

• "Clawbacks" Continue: CTA/NEA-Retired reps. continue to attend all CalSTRS meetings and continue to advocate for legislation that will end the outrage of **pension** "overpayment recovery." This is what happens when Districts misreport information to CalSTRS, pension amounts are inaccurately set, and the retiree later has to repay money, sometimes years later, when an audit catches the district's reporting error. CTA/NEA-Retired maintains that the school district should make CalSTRS whole, not the blameless retiree.

• Last year **Northbay** had all four General Membership meetings- three virtual and one in person that was outdoors in a vineyard. This year will begin with virtual and move to face to face meetings in Sonoma County and plan to hold meetings in the other areas we represent. Northbay is looking forward to an exciting year, with many new beginnings.
